1. Visit any Bank Branch near you with the Consolidated Demand Notice.
2. Present the consolidated demand notice number to the teller.
3. The teller will enter the demand notice number to validate and load your details.
4. Confirm your details in the preview page.
5. Make your payments via cash or cheque, and ensure it is processed through any of the following gateways: PayDirect, Etransact and Remita.
6. Ensure you obtain a receipt from the bank teller upon completing payment.
7. Bring the receipt to the ZIRS head office or any of our Tax stations to obtain your official ZIRS hardcopy receipt. You can also retrieve your E-receipt on the Payzamfara portal.
